### **Evading Arrest in a Motor Vehicle, Possession of Marijuana in a Drug Free Zone, Unlawful Possession of a Firearm by a Felon, Injury to an Elderly Monday June 1, 2015**



**Alfredo E. Perez:** On Saturday May 30, 2015 at 05:41 p.m., a patrol officer attempted to conduct a traffic stop on a silver 4 door sedan for a traffic infraction at the intersection of Ratliff and Scott Brown. The vehicle disregarded the officer and sped away. The vehicle travelled through several different streets and bailed on foot at the 500 block of Diana. The male subject went into a residence and was seen exiting out the rear door where the officer detained the male. He is identified as 28 year old Alfredo E. Perez. He was taken back to the vehicle where the officer located a cigarette containing marijuana in the center console. Perez was placed under arrest and charged with Possession of Marijuana in a Drug Free Zone and Evading in a Motor Vehicle. He was arraigned by Judge Benjamin Yudesis and his bond was set at 20,000 dollars.

**Ramiro Rodriguez Jr.:** On Saturday May 30, 2015 at 11:00 a.m., a San Benito Police Detective responded to the 600 block of Charlotte Street in reference to an investigation relating to a different possible crime. During the investigation the detective located a prescription bottle not labeled in plain view. Inside the bottle was a green leafy substance believed to be marijuana. The male subject who claimed ownership of the room it was located was identified as 51 year old Ramiro Rodriguez Jr. The marijuana had a weight of 0.33 ounces. Through interviews with family members, it was discovered that Mr. Rodriguez had several firearms in the home and had been convicted of several felony charges in the past. With consent from the owner of the residence, the detective located two .22 caliber pistols and two long rifles. Rodriguez was charged with Possession of Marijuana and Unlawful Possession of a Firearm by a Felon. He was arraigned by Judge Benjamin Yudesis and bond was set at 20,000 dollars.

**Rosa A. Conde:** On Friday May 29, 2015 at 09:51 p.m., a patrol officer was dispatched to the 500 block of Doherty in reference to an assault in progress. The officer arrived and made contact with the female victim. She stated 51 year old Rosa A. Conde arrived at her residence calling the victim names and struck her several times causing redness to her arms and chest. Conde was placed under arrest for the assault and was charged with Injury to an Elderly due to the victim being 65 years or older. She was arraigned by Judge Benjamin Yudesis and bond was set at 10,000 dollars.
