A Special Called Meeting of the San Benito Economic Development Corporation will be held on Thursday, July 27, 2023, at 12:00 PM.

At least a quorum of the Board will be participating by video conference or telephone call in accordance with the provisions of Sections 551.125 or 551.127 of the Texas Government Code that have not been suspended by order of the Governor.

Public comments must be emailed to the above address no later than Thursday, July 27, 2023, at 11:00 AM. The public comments submitted will be read aloud for the EDC Board of Directors to hear, and the content of the written comments may not exceed five (5) minutes.

To the extent practicable, all other public comment rules shall apply. The open portions of this meeting will be recorded, and meeting minutes will be made available to the public via the EDC website or upon request.


