PRESS RELEASE



ON WEDNESDAY MARCH 28, 2012 AT 12:10 PM. OFFICERS FROM THE SAN BENITO POLICE DEPARTMENT ARRIVED AT A RESIDENCE LOCATED ON THE 700 BLOCK OF COMFORT LANE IN ORDER TO EXECUTE SEVERAL FELONY/MISDEMEANOR ARREST WARRANTS ON TWO SUBJECTS. THE SUSPECTS WERE IDENTIFIED AS 31 YEAR OLD RICARDO "RICKY" ROBLES AND CLARISSA GARCIA. THE WARRANTS WERE ISSUED BY JUSTICE OF THE PEACE PCT 3-2 DAVID GARZA AFTER AN INCIDENT THAT OCCURRED AT THE LOCAL WALMART ON 03-19-2012 IN WHICH RICARDO ROBLES HAD APPARENTLY TAKEN SOME MERCHANDISE FROM THE STORE WITHOUT PAYING, AND HAD AN INFANT INSIDE THE SHOPPING CART WHEN FLEEING THRU THE PARKING LOT. DURING THE SAME INCIDENT CLARISSA GARCIA PICKED UP RICARDO ROBLES AT A NEARBY STREET AFTER COMMITTING THE CRIMES. UPON THE OFFICERS ARRIVAL AT THE RESIDENCE ON COMFORT LANE THEY WERE MET WITH OPPOSITION FROM FAMILY MEMBERS WHO DID NOT IMMEDIATELY ALLOW THE OFFICERS TO EXECUTE THE WARRANTS, BUT AFTER AN HOUR AND 14 MINUTES BOTH RICARDO ROBLES AND CLARISSA GARCIA WERE TAKEN INTO CUSTODY AFTER HIDING IN A CLOSET. IT SHOULD ALSO BE NOTED THAT A FAMILY MEMBER IDENTIFIED AS 17 YEAR OLD ADRIENNE GARCIA WAS ALSO ARRESTED AT THE SCENE FOR HINDERING APREHENSION. ALL SUBJECTS WERE THEN TRANSPORTED TO CITY JAIL WHERE THEY WERE BOOKED IN ACCORDINGLY. MUNICIPAL JUDGE ADOLFO CORDOVA ARRAIGNED ALL SUBJECTS. RICARDO ROBLES WAS ARRAIGNED ON CHARGES OF FELONY ABANDONING OR ENDANGERING A CHILD, THEFT CLASS B MISDEMEANOR, CRIMINAL TRESPASS CLASS B MISDEMEANOR AND HIS BONDS WERE SET AT \$ 15,000.00 DOLLARS. CLARISSA GARCIA WAS ARRAIGNED ON CHARGES FOR FELONY ABANDONING OR ENDANGERING A CHILD, CRIMINAL TRESPASS CLASS B MISDEMEANOR AND WAS REALESED ON A \$7,500 PERSONAL RECOIGNASANCE BOND. ADRIENNE GARCIA WAS ARRAIGNED ON TWO COUNTS OF HINDERING APREHENSION AND WAS ALSO RELEASED ON A \$7,500.00 PERSONAL RECOIGNASANCE BOND FOR EACH COUNT.
