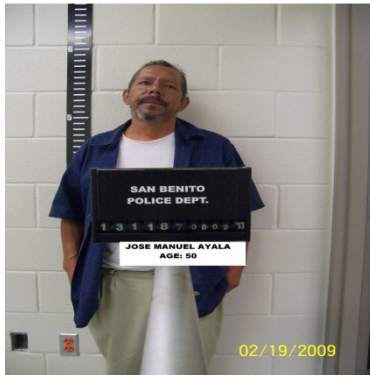

DRIVING WHILE INTOXICATED

MONDAY AUGUST 5TH, 2013



JOSE MANUEL AYALA. On Friday August 2nd, 2013, at 9:50 pm, A San Benito Police Officer observed a gray Nissan pickup truck traveling by the 300 Block of West Stenger with defective equipment. The Police Officer then initiated a traffic stop, and made contact with 50 year old Jose Manuel Ayala who presented signs of impairment due to alcohol consumption. The driver was then asked to perform a field sobriety test but he refused. Driver was then taken into custody, and transported to City jail where he agreed to provide a breath specimen that showed that he had a blood alcohol content over the legal limit. The suspect's criminal history revealed numerous arrests for DWI enhancing the offense to a 3rd Degree Felony. Jose Manuel Ayala was arraigned by Municipal Judge David Garza on DWI 3rd or more who was released on a \$2,000 personal recognizance bond.

CUSBERTO ROBERT SANCHEZ. On Friday August 2nd, 2013, at 10:26 pm, a San Benito Police Officer observed a maroon 4 door Buick Regal traveling at a high rate of speed by Diaz street, and later making a moving violation. The Officer then initiated a traffic stop on the maroon Buick by the 900 block of Combes Street. The Police Officer then made contact with the driver who was identified as 41 year old Cusberto Robert Sanchez who presented signs of impairment due to alcohol consumption. The driver then performed a field sobriety test, and was asked for a breath specimen but refused. Cusberto Sanchez was then taken into custody, and taken to City Jail where he was booked on DWI refusal. Offense was enhanced to a class A misdemeanor due to having a prior conviction for DWI. Suspect was arraigned by Municipal Judge David Garza who released the suspect on a \$3,000 personal recognizance bond.

ALVARO MARTINEZ MONTOYA. On Monday August 5th, 2013, at 02:22 am, A San Benito Police Officer observed a grey Jeep Cherokee traveling north on Sam Houston Boulevard commit a moving violation, and pulled the Jeep Cherokee over by the 200 Block of North Sam Houston. Contact was then made with the driver who was identified as 33 year old Alvaro Martinez Montoya who presented signs of impairment due to alcohol consumption. Driver then agreed to perform a field sobriety test, and was later asked by the Police Officer to provide a breath sample to which Alvaro Montoya agreed. Driver was then taken to the Police station where a breath test showed that the driver had a blood alcohol content over the legal limit. Alvaro Martinez was placed under arrest for DWI, and later arraigned by Municipal Judge Ben Yudesis who set bond at \$5,000. Suspect was taken to the Cameron County Jail with an immigration detainer issued by ICE.
