All inspection requests shall be the responsibility of the contractor, giving **24 hour** notice prior to inspection. This permit becomes **NULL** and **VOID** if authorized construction is not commenced within 6 months. If construction is not completed within **1 YEAR**, a new permit must be obtained at construction value only. I have read and examined this application and know the same to be true and correct, and that all provisions of laws, ordinances and codes governing this type of work will be complied with whether specified herein or not, and the granting of a permit **DOES NOT** presume to give authority to violate or cancel the provisions of any other state or local law regulating the performance of construction.
