Construction Requirements to include all types of construction listed on page 1:

*I hereby agree to comply with City of San Benito ordinances, codes and state laws and assume all responsibility for such compliance, and that a Certificate of Occupancy will not be issued until construction is completed. Any deviation, modification or change from the plans or other documentation submitted will be declared a violation of this permit, unless authorization is given and upon submitting the corresponding plans showing the same. All waste, garbage and dumpster pickup must be supplied by REPUBLIC SERVICES (956)423-7316. All permits must be secured separately: electrical, plumbing, HVAC and irrigation. All inspection requests shall be the responsibility of the contractor, giving **24 hour** notice prior to inspection. This permit becomes **NULL** and **VOID** if authorized construction is not commenced within 6 months. If construction is not completed within **1 YEAR**, a new permit must be obtained at construction value only. I have read and examined this application and know the same to be true and correct, and that all provisions of laws, ordinances and codes governing this type of work will be complied with whether specified herein or not, and the granting of a permit **DOES NOT** presume to give authority to violate or cancel the provisions of any other state or local law regulating the performance of construction.

ALL INCOMPLETE PACKAGES WILL DELAY YOUR BUILDING PERMIT BEING ISSUED ON A TIMELY BASIS. NO BUILDING PERMITS WILL BE ISSUED FOR ANY COMMERCIAL CONSTRUCTION WITHOUT THE FOLLOWING.

Builder must register with the City of San Benito as a general contractor (sub-contractors to register in their specialized field).

COMMERCIAL PROJECTS: *Other requirements may apply, pending proposed use

- 1) Two (2) full sets of plans (24 IN X 36 IN) will include list (a-g). ALL Commercial Construction plans that meet items **a)** 5,000 sq. ft or larger **or b)** Occupancy type A=Assembly or I=Institutional is required to have a Certified Engineers signature and seal.
 - a. Electrical load calculations and panel diagrams.
 - b. Plumbing details.
 - c. HVAC layout and load calculations.
 - d. Foundation plan to include wood, steel or engineered post tension w/details.
 - e. Typical wall section.
 - f. Exterior elevations (all four sides).
 - g. Roof section with joist and rafter layout, or engineered roof truss layout and dimensions.
 - h. Location of storm water silt fence, BMP-SWP3, location of construction drive way, concrete clean out and location of portable toilet.

- 2) Submit Plot Plan/Site Plan showing:
 - Address of property
 - Legal description of the property
 - Building setback lines
 - Parking – 9' X 20' to be of asphalt or concrete
 - Landscaping – 10% of gross building site area
 - Sidewalks with locations and sizing
 - Location, type and dimensions of fencing
 - Trash bin location, and screening enclosure

- 11) Fire Alarm Specifications/Plans.
- 12) Fire Sprinkler System plan (ISO review required prior to submittal)
- 13) Smoke Alarm System and/or Fire Extinguishers

The following items require separate permits:

- Signage Permit
- Fence Permit
